Of Evotec's current capital stock of Euro 149,853,449.00, divided in 149,853,449 non-par value bearer shares, 89,049,893 shares were represented at the time of the voting procedure, each with one vote. This corresponded to 59.42% of the current capital stock of the Company and 59.74% of the registered capital stock of the Company. The Company holds currently 249,915 own shares. The Company has no rights in respect of these shares.

Each resolution suggested by the Management and Supervisory Board or the Supervisory Board only, as published in the German Federal Gazette on 9 May 2019, was voted on.
